First Amendment to the Regulations of Karlsruhe Institute of Technology (KIT) Governing Disciplinary Measures

of April 27, 2023

Pursuant to Art. 10, par. 1 and Art. 20, par. 2 of the Act on Karlsruhe Institute of Technology (KIT Act – KITG) of July 14, 2009 (Bulletin pp. 317), last amended by Art. 2 of the Act on the Amendment of the Act of Baden-Württemberg on University Hospitals and Other Acts (Gesetz zur Änderung des Universitätsklinik-Gesetzes und anderer Gesetze) of November 15, 2022 (Bulletin, p. 585) and Art. 62 a, par. 3, cl. 2 and Art. 12, par. 3 of the Act of Baden-Württemberg on Universities and Colleges (Landeshochschulgesetz, LHG) of January 1, 2005 (Bulletin pp. 1), last amended by Art. 8 of the Act on Adoption of the Climate Protection and Climate Change Adaptation Act and on Inclusion of Climate Protection Matters in Other Legal Regulations (Gesetz zum Erlass eines Klimaschutz- und Klimawandelanpassungsgesetzes und zur Verankerung des Klimabelangs in weiteren Rechtsvorschriften) of February 7, 2023 (Bulletin, pp. 26, 43), the KIT Senate in its meeting on January 30, 2023 adopted the following First Amendment to the Regulations of Karlsruhe Institute of Technology (KIT) Governing Disciplinary Measures of April 12, 2022 (Official Announcements No. 22, pp. 151).

The Executive Board of KIT approved this amendment according to Art. 62 a, par. 3 LHG on February 27, 2023.

Article 1 – Amendment to the Regulations Governing Disciplinary Measures

1. Article 3, par. 2, cl. 2 is changed as follows:

“The term of office of members according to par. 1, cl. 2, Nos. 1 through 4 is two years, that of members according to par. 1, cl. 2, Nos. 5 and 6 one year.”

2. In Article 5, par. 7, the following clause 7 is added:

“Article 17 of KIT’s Rules of Procedure applies accordingly.”

3. In Article 7, par. 1, clause 2, second part: “Article 18 a” is replaced by “Article 18”.

Article 2 – Entry into Force

This amendment will enter into force on the day after its publication in the Official Announcements of KIT.
